**Instructions**: Complete this section if the student and/or spouse <u>filed or will file</u> a 2019 IRS income tax return. **The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at <u>FAFSA.gov</u>.** In most cases, no further documentation is needed to verify 2019 IRS income tax return information that was transferred into the student's FAFSA using the IRS DRT if that information was not changed.

In most cases, for electronic filers, 2019 IRS income tax return information for the IRS DRT is available within 2–3 weeks after the 2019 electronic IRS income tax return has been accepted by the IRS. Generally, for filers of 2019 paper IRS income tax returns, the 2019 IRS income tax return information is available for the IRS DRT within 8–11 weeks after the 2019 paper IRS income tax return has been received by the IRS.
